## Progress Update

### **Progress Update**



- Subcontracts in progress for capital equipment purchasing
- Advisory committees minimally constituted
  - NORDTECH will be looking for more members to join these committees
- Administrative staff assigned
  - Technical Director, Interim Program Director, Finance Manager
- Three hub start-up deliverables achieved
  - Hub model, members meeting, and kick off meeting with NSTXL/USG





## Work in Progress

### Work In Progress



- Membership Model and Agreement
  - <u>Near term action</u>: We consider institutions de facto members via a letter of support or membership application at <u>https://nordtechub.org/contact</u>
  - Future: Once by-laws and committee charters are finalized a membership agreement will be available to execute to maintain official membership
- Expand Member Involvement in Advisory Committees
  - <u>Near term action</u>: soliciting volunteers to assist with CFP proposal review via the form located at <u>https://nordtechub.org/volunteer</u> by Friday, 12/15
  - Future: Based on the by-laws and membership agreement, more members will be added to the Technical, Workforce, and Facility Advisory Committees. A separate Defense Advisory Committee to be established.
- IT Infrastructure Working Group
  - Future: Enhanced communications tools and a comprehensive member portal





## Call For Projects Status

### **Call For Projects Status**



- The Call for Projects is expected to be released on or about December 15<sup>th</sup> with ~60 days to respond.
- Each hub may only submit up to 15 proposals total.
  - Therefore, NORDTECH has 60 days to down select the best proposal ideas AND develop the best full proposal to submit to NSTXL.
  - If a proposal, or any part of a proposal, is being submitted to multiple hubs, this must be declared during submission for review by the hub(s).
  - Projects not selected are prime candidates for the next Call for Topics (CFT).

## Call For Projects Plan


### **Call For Projects Plan**



- NORDTECH will push the CFP documents from NSTXL to our email distribution list ASAP after release.
- NORDTECH will provide a four-page summary document which is due within two weeks.
  - This summary will allow the advisory committees to review, rate, and down select to the 15 concepts to be developed into a full proposal.
- Initial feedback will be provided after week three, with the major go/no-go decision coming in week four from the Governance Committee.
- Each project moving forward will have a lead entity owning the complete full proposal package as requested from NORDTECH per the CFP/NSTXL.
  - Lead entity will provide technical, proposal manager and administrative support
  - Lead entity will provide full technical volume, pricing, and other required documents
- Lead entities can start the full proposal, at-risk, based on initial feedback.
  - NORDTECH will provide proposal package and a kickoff with the Lead Entity proposal team (Technical Lead, Proposal Mgr, and Administrative Lead)
- Final two weeks of the process are reserved for NORDTECH review of Lead Entity Project Proposal for completeness and compliance reviews prior to submission by RF SUNY.

#### **NORDTECH Actions**

- Participant email sent out with 4-pager submission instructions
- TAC, WAC, FAC Assessment
  Preliminary
  - Feedback to Leads
- GAC review and selection
- Point of contact assigned for each project proposal
  Peer review/feedback
- Final peer review, white glove treatment, compliance checks
- Submission to NSTXL

#### **Project Lead Actions**

- Develop and submit 4-pager via NORDTECH website
- Begin full proposal based on preliminary feedback (at-risk)

Develop full submission packages including technical and financial volumes based on templates from NORDTECH

#### • Applicability to Mission

What is the TRL? What DOD mission capability is this project advancing? Provide DOD-specific examples.
